MINUTES OF A MEETING OF THE UNIVERSITY SENATE February 14, 2005

1. Senator Spiggle officially called the regular meeting of the University Senate of February 14, 2005 to order at 4:04 p.m. in Room 7 of the Bishop Center.

2. Approval of Minutes

Senator Spiggle presented the minutes from the regular meeting of December 13, 2004 for review.

The minutes were approved without modification.

3. Report of the President

President Austin summarized recent developments:

- a. Public Health Initiative Collaborative discussions between the Storrs campus and Health Center faculty are taking place.
- b. Graduate student expenses on federal grants Provost Nichols will address this issue on his arrival by appointing a broad-based group to achieve consensus and make a recommendation.
- c. Budget UConn Administrators are working with State Legislators to recommend a budget effective for UConn and the students and families of Connecticut.
- d. President Austin announced that he recently accepted the Chairpersonship of the New England Public Colleges and Schools, the Big East President representative to the NCAA Division 1A Board of Directors, and the Chairpersonship of the NCAA board.
- e. UConn 2000 University has redistributed resources to deal with the cost overruns at the Student Union and the Biotechnology Buildings and has made some relate employee organizational changes.

President Austin addressed questions from the Senate which included the Research Advising Council's suspension of the major grants program and questions related to the University's budget.

Motion: Amendment to the Laws, By-Laws, and Rules of the Board of Trustees Board of Trustees, Article X.A.

Recommendation: That the Board of Trustees amends Article X–The University Senate, A. Membership, of the University of Connecticut <u>Laws and By-Laws</u>, as here described.

ARTICLE X – THE UNIVERSITY SENATE

A. Membership

The University Senate shall consist of *ex officio* and elected members. The *ex officio* members shall be the President, the Provost and Executive Vice President for Academic Affairs, the <u>Senior</u> Vice President and Chief Financial Officer, <u>the Senior Vice President and Chief Operating Officer</u>, <u>the Vice Provost for Multicultural and International Affairs</u>, the Vice Provost for Research and Graduate Education and Dean of the Graduate School, <u>the Vice Provost for Enrollment</u>

<u>Management</u>, the Vice <u>Chancellor President</u> for Student Affairs, the Vice <u>Chancellor Provost</u> for Academic <u>Administration Affairs</u>, the Vice <u>Chancellor President</u> for <u>Business and Administration Operations</u>, <u>the Vice President and Chief Information Officer</u>, the Vice <u>Chancellor Provost</u> for <u>Information Services and University Librarian Libraries</u>, and the Vice Provost for <u>Undergraduate Education and Instruction Academic Programs</u>, and the Associate Vice President for Human <u>Resources</u>. These *ex officio* members shall not vote.

The motion carried.

Senator Moiseff presented the following motion on repeating courses.

The Senate Scholastic Standards Committee proposes the following motion to revise the section of the Rules and Regulations of the University Senate dealing with repeating courses.

Proposed revision:

BY-LAWS, RULES, AND REGULATIONS OF THE UNIVERSITY SENATE II. RULES AND REGULATIONS
B. Academic Advising and Registration

9. Repeating Courses

Any student who is regularly registered for any course and who satisfies the requirements shall receive credit therefore, except that no student shall receive credit [delete: toward the degree] for the same course twice, unless it is specifically so stated as in a variable content course. Courses with the same first three numbers that cover the same course content cannot be counted more than once for credit toward the degree. The parenthetical phrases (Formerly offered as...) and (Also offered as...) that follow a course title as a cross reference indicate that a student may not take both the course and the cross-referenced course for credit toward the degree. A student is regularly registered for a course only when in registering he or she has conformed to all university or college regulations or requirements applying to registration for the course.

A student may repeat a course previously taken one time without seeking permission in order to earn a higher grade. The student may take the course a third time with the permission of the dean or of the school or college in which the student is enrolled and the instructor of the course. **Under no circumstances may a student take a course more than three times.**

When a student repeats a course, credit [delete: toward the degree] shall be allowed only once. Furthermore, in the computation of the grade point average, the registered credit and grade points for

the most recent taking of the course shall be included in the GPA calculation and the registered credit and grade points for the prior taking of the course shall remain on the transcript, but shall be removed from the GPA calculation

When a student repeats a course after receiving a degree, the student's transcript will indicate a grade, but no registered credit, for the repeated course. The grade and registered credit recorded for the course prior to receipt of the degree shall continue to be included in the GPA and credit calculations.

Senator Gramling proposed an amendment to delete the words "the first three" in the first paragraph, second sentence.

The amendment was seconded by Senator Zirakzadeh.

The motion to amend carried.
